The metropolitan planning organization (MPO) in cooperation with the designated recipient of federal formula transit grants (City of Raleigh/GoRaleigh) for the Raleigh, North Carolina, Urbanized Area seeks your assistance with the distribution of the FFY 2020 Section 5307 / 5340 and Section 5339 Federal Transit Administration (FTA) formula apportionments. The proposed apportionments outlined below were mutually agreed upon by the City of Raleigh/GoRaleigh, GoTriangle, Town of Cary/GoCary, and Wake County.
