



Interlocal Agreement Overarching Structure:



 CAMPO and GoTriangle supported by Transit Planning Advisory Committee (TPAC) comprised of technical staff to advise boards on technical decisions





8.2 Wake County Transit Investment Strategy Implementation Role:

Transit providers and municipalities in Wake County enter into project agreements with GoTriangle.





CAMPO Executive Board and GoTriangle Board of Trustees Decisions

Annual Wake Transit Work Plan:

- Developed by TPAC or Agency Delegated by TPAC (e.g., GoTriangle, CAMPO, etc.)
- Includes the Following Items:
 - Annual Capital and Operating Project and Tax District Administration Budgets
 - Multi-year Capital and Operating Programs Updated Annually
 - Annual Financial Model Updates and Update to Wake Transit Financial Plan
 - Capital and Operating Project Agreements
- Boards Consider and Take Action on Items Simultaneously

- Determine agencies responsible for admin staffing of TPAC and development of boards' decision items and other policies/programs under TPAC and Boards' purview
- Develop multi-year service implementation plan
- Develop program management policy and plan for community funding areas
- Develop templates/minimum standards for annual reports
- Develop project prioritization policy guiding development of multi-year capital and operating programs
- Recommend designation of project sponsors
- Determination of how changes from adopted plans should be handled
- Development of public involvement strategy for work plan and other TPAC products



Roles/Responsibilities of Parties:

GoTriangle:

- Administer/manage tax district finances
- Enter into and enforce operating/capital agreements
- Provide financial and project status reports

CAMPO:



- Call meeting of Conference Committee, if needed








Study Area

Existing Rail Crossings








Purpose of the Study

- Evaluate potential improvements to the at-grade roadway/rail crossings
- Consider possible new roadway extensions across the railroad
- Study how changes at the crossings will affect future land uses and the community

- Bicycle and pedestrian network additions




Public Outreach


Vision, Issues, and Opportunities: **Strengths**




Design Principles

- Build safety through urbanization
- 2. Choose the paths of least resistance
- Invest in crossings that leverage the corridor's strengths
- Invest in crossings that respond to critical issues
- 5. Invest in crossings where significant development potential exists
- Balance regional transportation and local circulation needs

Design Assumptions

- Incorporated adopted transportation plans
- 200-foot rail corridor
- No change to railroad elevation or alignment
- Consistent with 2015 Draft Recommended Wake County Transit Plan



Railroad bridge example




Road bridge example

7. Public Hearing7.2 Public Participation Plan Update

The Capital Area MPO has a Public Involvement Plan that describes how the MPO involves the public in developing transportation plans and related policy documents.

The MPO staff reviewed the existing plans, and then looked at other "best-practices" plans from around the state and similar MPOs around the nation. The document presented here today does 4 things:

- Updates the format of the document to be more user-friendly and easy to understand
- Updates specific parts of the document to reflect improvements in the planning process and recognize changes in modern communication and media.
- Adds adopted Strategic Plan goals related to public participation by reference and leaves a placeholder reference for related 2045 MTP goals & measures;
- Adding or making clearer what the public participation requirements are for adopting, amending, or correcting plans or other required documents. This was mostly clarifying actions for sub-plans or processes not directly addressed in the current plan.
- Staff released the draft Public Involvement Plan Update for public review and comment from February 25, 2016 through April 20, 2016.
- FHWA reviewed and requested some technical corrections and the addition of an explanation of acronyms before they appear; they also recommended keeping the Title VI/LEP plan as a separate document.


