Wake Transit Community Engagement Policy 2022

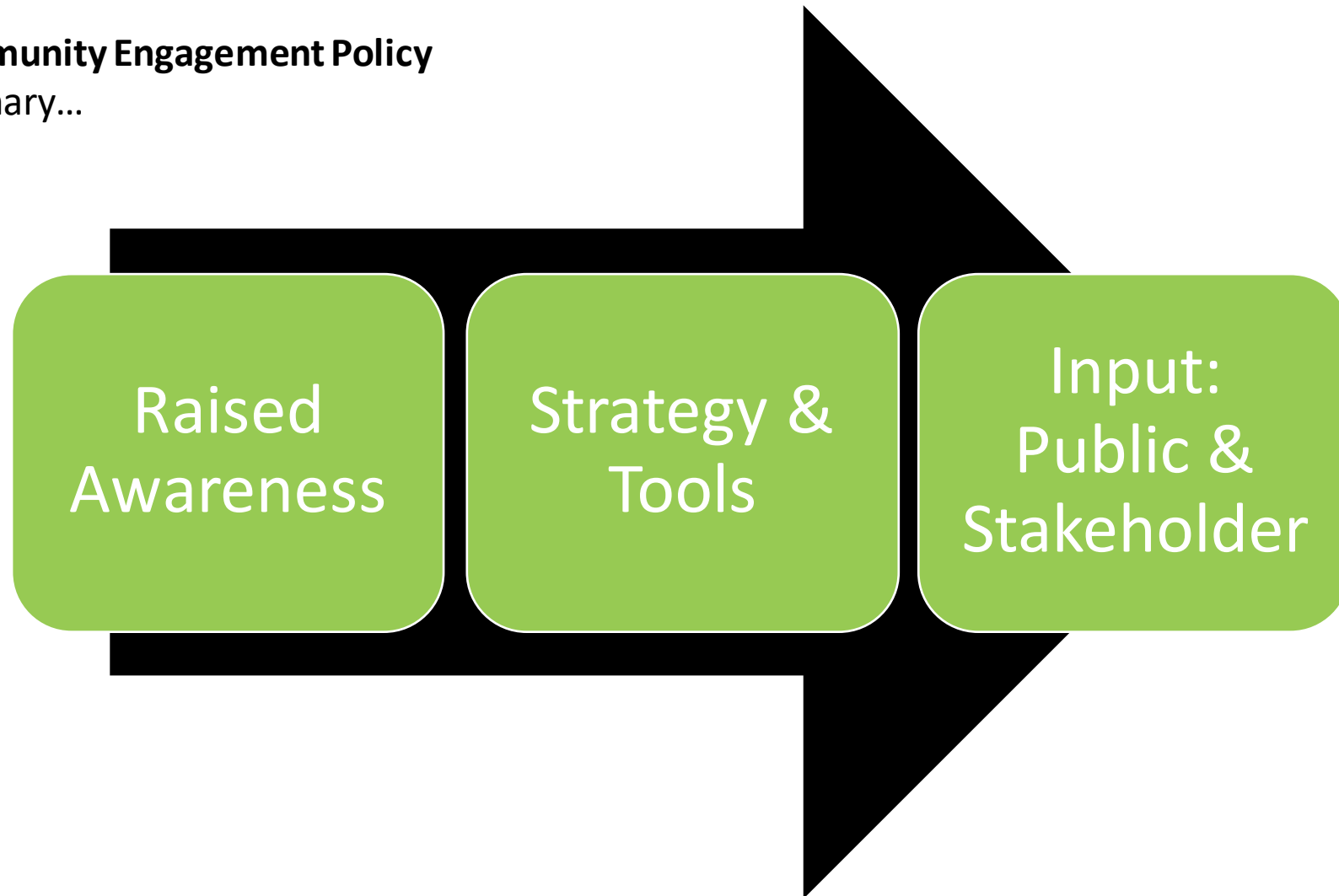
This policy updates the Wake Transit Public Engagement Policy, which was adopted in 2018.

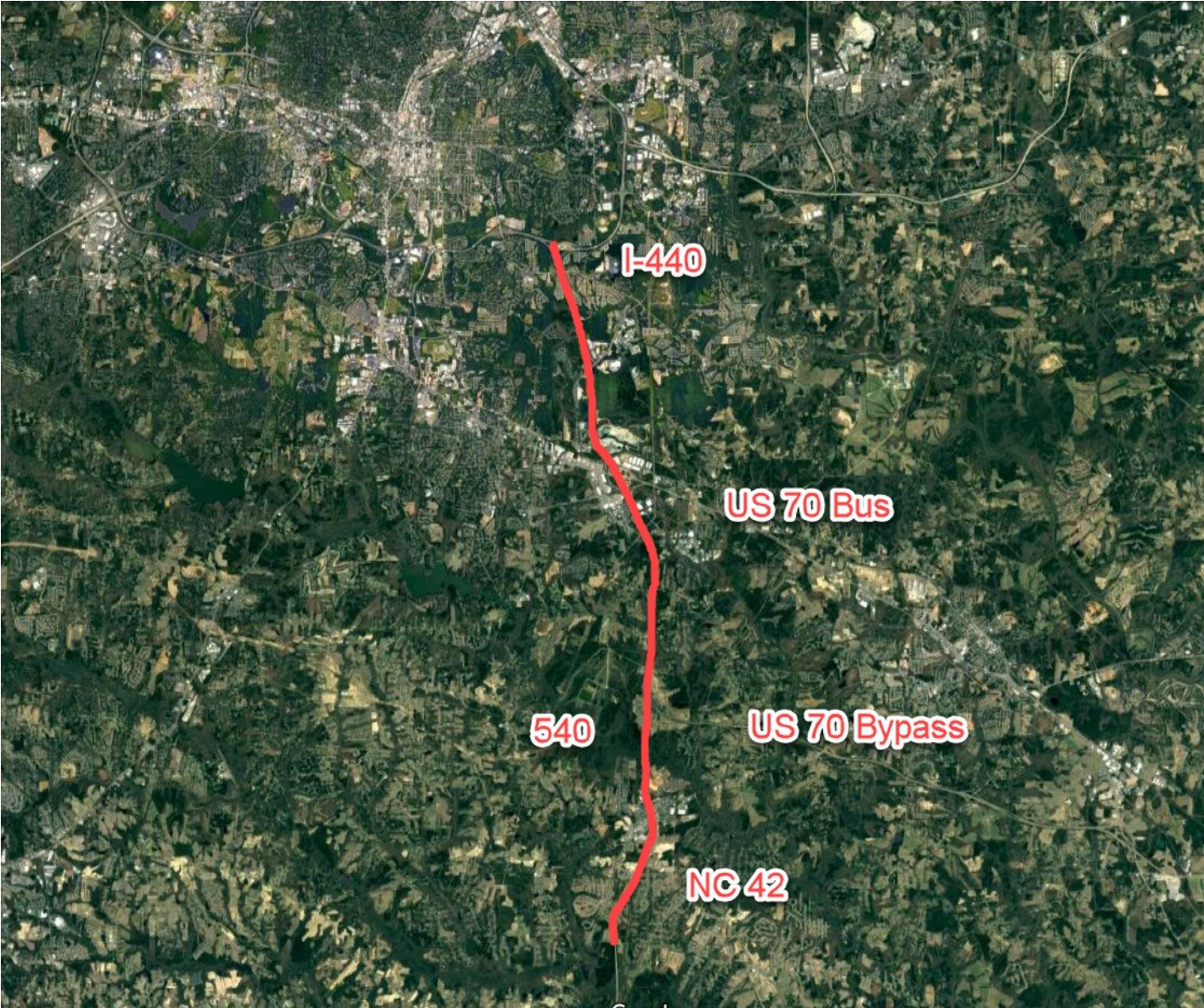

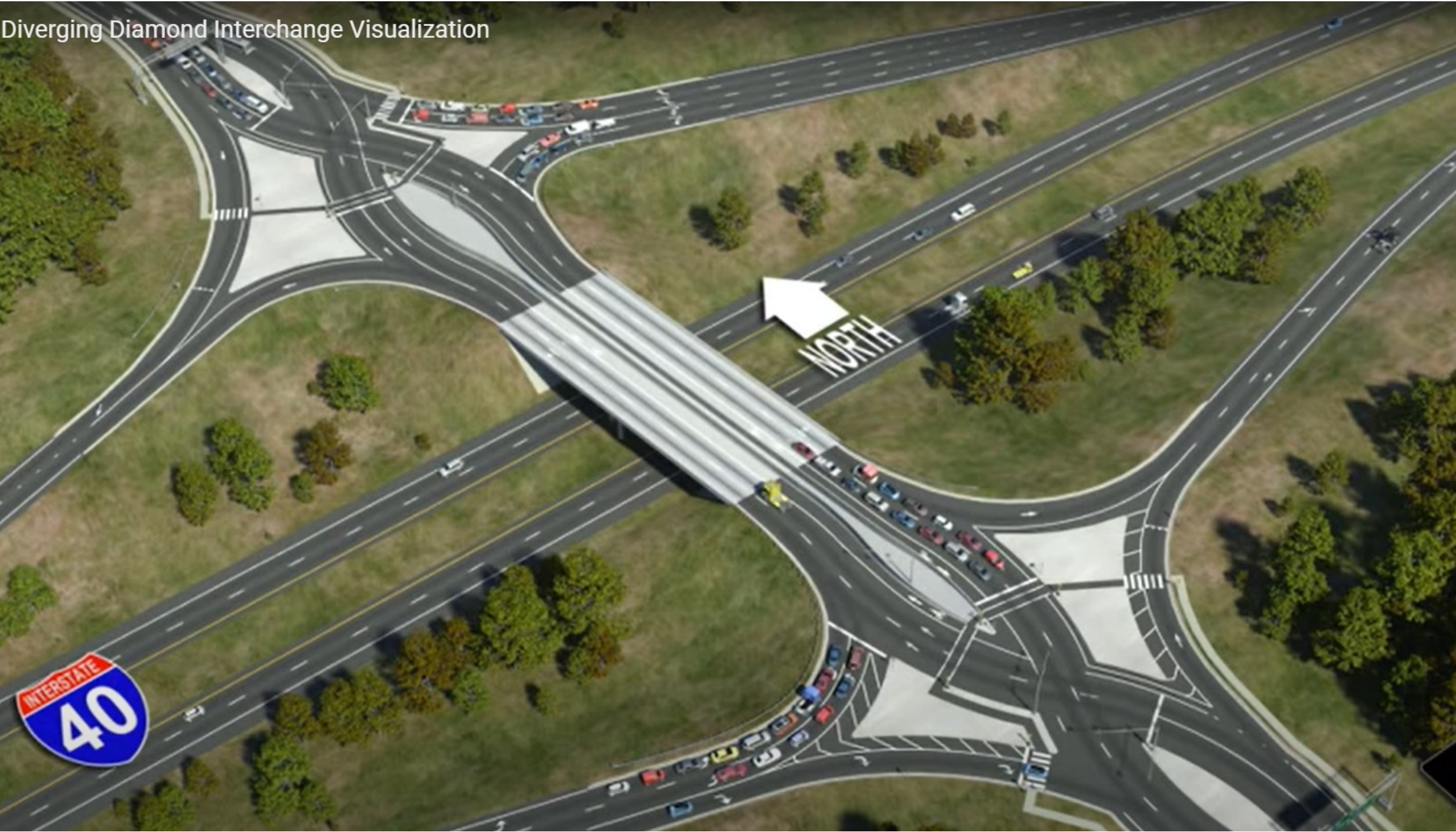




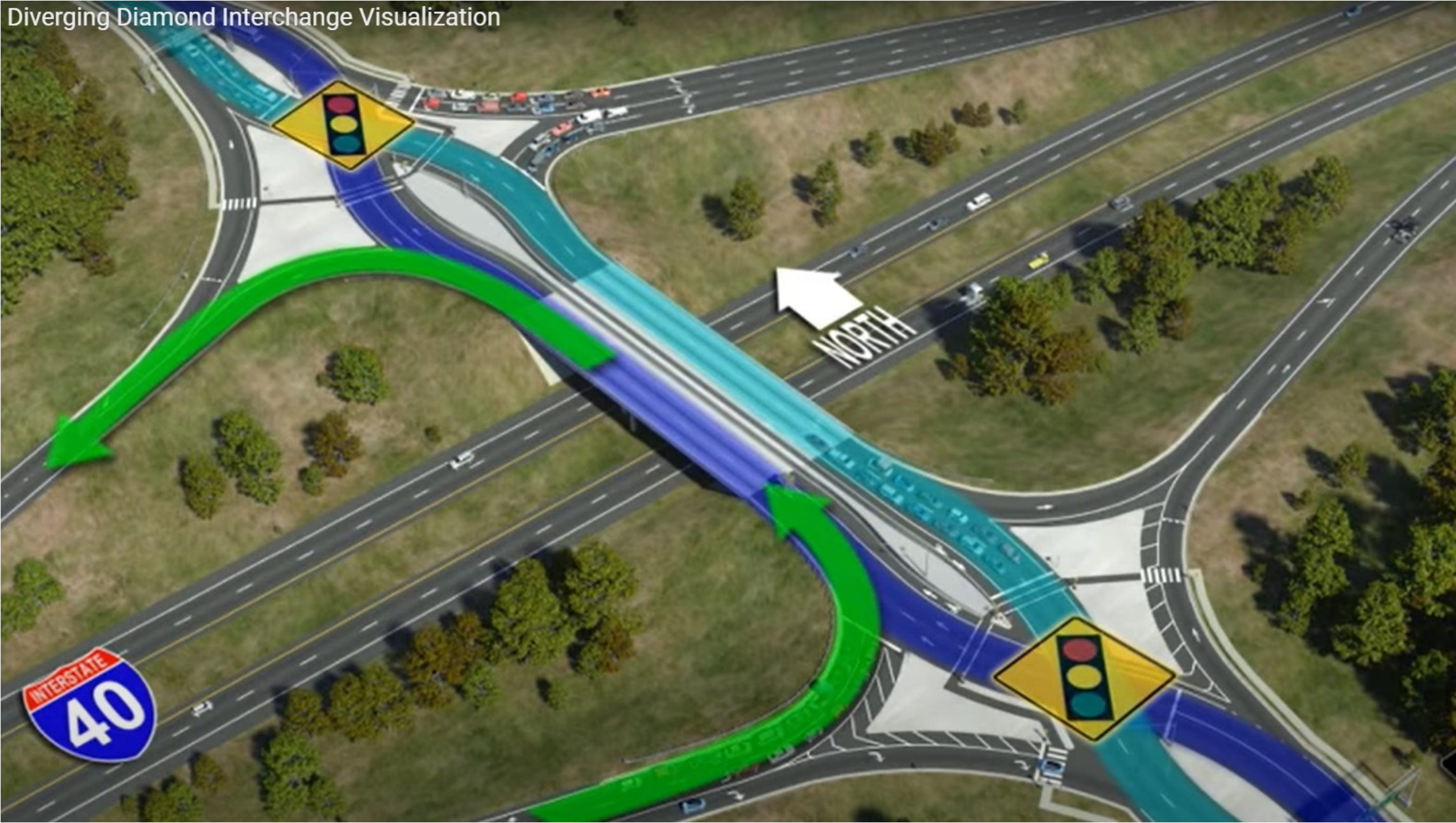




Diverging Diamond Interchange Visualization

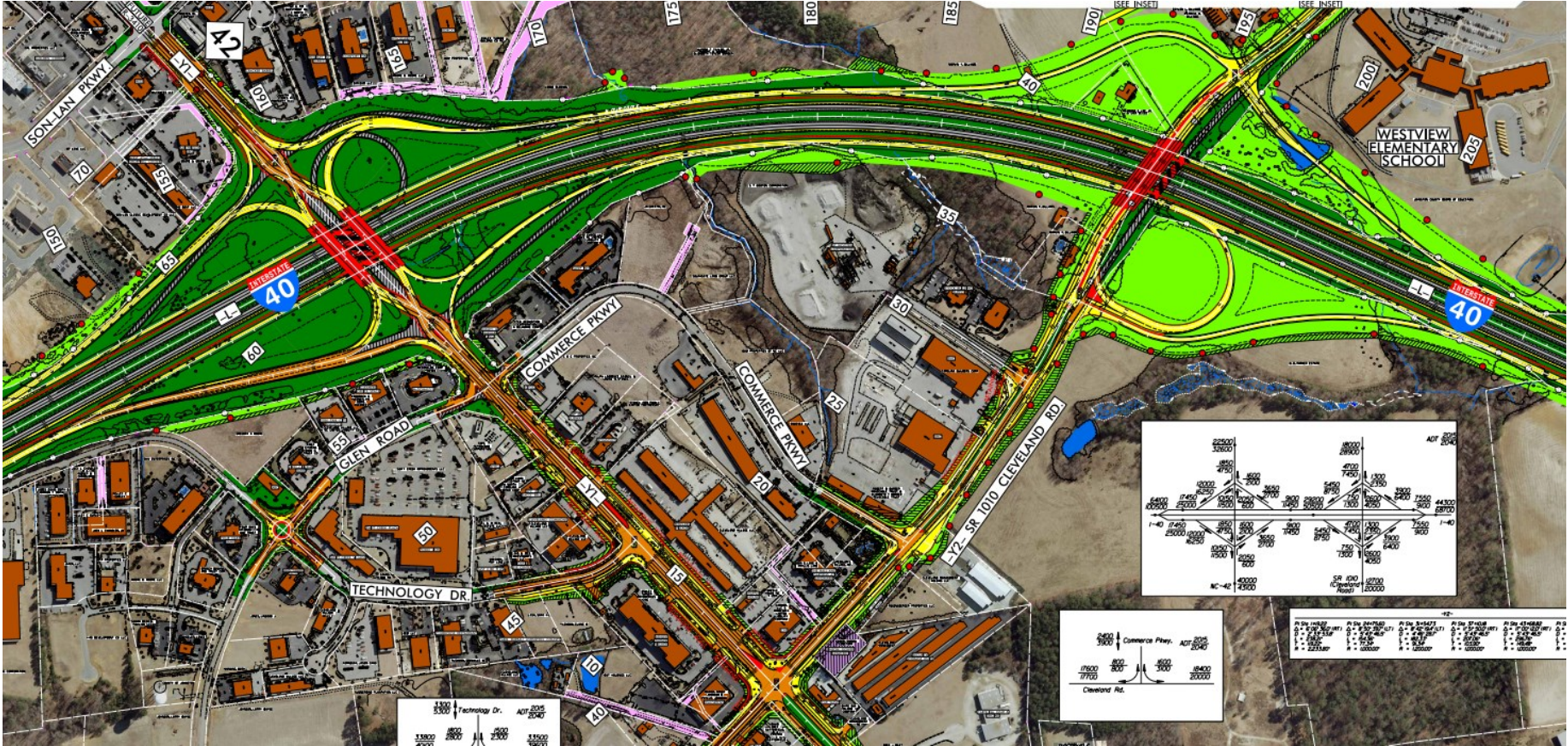
















I-5111/I-4739 Next Steps

 - May 2023
- Cleveland School Road Access opens
 - Fall 2023
- NC 42 DDI opens
 - Late 2023/Early 2024
- Overall Completion Date
 - August 2024

U-6093 Rock Quarry Road Timeline

- Duke/Spectrum/AT&T relocations complete soon
- Water/Sewer work commences followed by drainage
