# **LAPP Mid-Year Milestones, April 2016**

There's approximately four months left before the system closes for FFY16 Authorizations. The following is a status update on programmed projects according to municipal agency, including:

- a) Prior year projects (FFY15 and earlier) that are <u>behind schedule</u>, based on the original schedule when the project was awarded LAPP funds. This includes projects that have not authorized the phase listed, as well as one project that received authorization, and
- b) Current year projects (FFY16) that are <u>on schedule</u> but have only four months to receive authorization/obligation (and are at risk of becoming behind schedule since we are entering the busy review time of the year).

Projects with multiple phases yet to be authorized and those with large amounts of ROW transactions will have the most difficulty achieving authorization prior to the end of the federal fiscal year. In May, the LAPP Committee will be convened to discuss the issue of behind-schedule projects. Staff will make policy recommendations for enforcing schedules, in an effort to limit the number of behind-schedule projects per agency.

## ❖ APEX

#### **ROADWAY**

- 1. U-5537 Lake Pine (14, ROW & 15, CON). This is a joint Apex/Cary project, which is currently 2 years behind schedule. ROW authorization is anticipated soon (May) and includes 5 private parcels, in addition to Town-owned easement amendments. Apex is working to reach construction authorization at the end of FFY16.
- 2. U-5118AE NC 55 / Apex Peakway / Olive Chapel Road OI (15, CON). This project is <u>1 year behind</u> schedule. It is currently in ROW acquisition (2 parcels) and construction authorization is anticipated at the end of FFY16.
- U-5118AF Kelly / Olive Chapel Road OI (15, ROW & CON). This project is 1 year behind schedule. It is anticipated to start ROW acquisition (1 parcel) in the next month. Construction authorization is anticipated at the end of FFY16.

#### CARY

#### ROADWAY

- U-5117 Walker Street Bridge (11, ROW). This project is <u>approximately 4 years behind</u> schedule, with funding authorized but not utilized. The project is currently inactive pending a TIGER grant request.
- 2. U-5315 Morrisville Parkway Extension (15, CON). The agreement has not been finalized on this project. The project schedule changed twice, delaying a year each time so that the roadway project would be completed with the interchange project. It is currently 2 years behind schedule. Right-of-way acquisitions were initiated in March 2016. This project is currently scheduled for construction authorization in FFY17.
- 3. U-5537 Lake Pine (14, ROW & 15, CON). This is a joint Apex/Cary project, which is currently 2 years behind schedule. ROW authorization is anticipated soon (May) and includes 5 private parcels, in addition to Town-owned easement amendments. Apex is working to reach construction authorization at the end of FFY16.
- 4. C-5165 Cary Parkway / High House Intersection Improvements (15 CON). This project is currently <u>2 years behind</u> schedule, ROW acquisition (12 parcels) started in March 2016. Construction authorization is anticipated to be delayed until FFY17.
- 5. U-5500B Green Level West Road Widening (16, CON). This project is <u>on schedule</u>, currently in ROW acquisition (12 transactions) with construction authorization anticipated by the end of FFY16.

# CARY, continued

### BIKE/PED

- U-5530IB White Oak Creek Greenway ATT Connection (15, CON). This project is currently <u>1 year behind</u> schedule. ROW acquisition is being undertaken now (4 parcels) and plan changes are being made to accommodate recent approvals by Apex. Construction authorization is anticipated at the end of FFY16.
- C-5163 Crabtree Creek Greenway (15 & 16, CON). Phase I was delayed to coincide with Phase II FFY16 funding so this project is <u>on schedule</u> (as amended) and currently completing PS&E. Construction authorization is anticipated by the end of FFY16.
- C-5604IA Panther Creek Greenway & Trailhead (16, CON). This project is <u>on schedule</u>, has completed PCE, does not have ROW and construction authorization is anticipated by the end of FFY16.

## **❖** CREEDMOOR

#### BIKE/PED

- 1. C-5166A NC55 East Greenway (15, CON). This project is <u>1 year behind</u> schedule, currently in ROW acquisition (12 of 19 parcels complete) and anticipated to reach construction authorization at the end of FFY16.
- 2. C-5166B NC55 West Greenway (15, CON). This project is <u>1 year behind</u> schedule, currently in ROW acquisition (27 of 37 parcels complete) and anticipated to reach construction authorization at the end of FFY16.

## **ROADWAY**

- 1. W-5601AB Roundabout at NC96 & NC98 (16, CON). This project is <u>on schedule</u> with construction authorization anticipated at the end of FFY16.
- 2. W-5601BC NC 42 at SR 2736 (16, CON). This project is <u>on schedule</u> with construction authorization anticipated at the end of FFY16.

## **❖** FUQUAY-VARINA

### BIKE/PED

 U-5530GB Bridge Street Pedestrian Improvements (16, ROW & CON). This project is on schedule, starting ROW soon (20 parcels) with construction authorization anticipated at the end of FFY16.

## BIKE/PED

1. U-5530KA Butner to Creedmoor Greenway (13/14 CON & 16 CON). This project is anticipated to be <u>1 year behind</u> schedule (as amended) with construction authorization anticipated in FFY17.

## **ROADWAY**

1. U-5529 Avent Ferry Road Operational Improvements (15, ROW & 16, CON). This project is <u>1 year behind</u> schedule with ROW anticipated to start soon. There's minimal ROW acquisition required, so construction authorization is anticipated at the end of FFY16.

#### BIKE/PED

- 1. U-5530MA Morrisville Church Street Sidewalk (14, CON). This project is <u>2 years behind</u> schedule.
- 2. C-5168 Crabtree Creek Greenway (13, PE & 15, CON). This project is <u>1 year behind</u> schedule and anticipated to reach construction authorization before the end of FFY16.

## **ROADWAY**

B-5121/B-5317: Capital Blvd/Peace St. Interchange Enhancements (15, ROW & 16, CON).
 The project is being implemented by Division 5 and is on schedule to let construction in June.

### BIKE/PED

- C-5604OA New Bern Avenue Pedestrian Improvements (16, ROW & CON). This project is already determined to be <u>1 year behind</u> schedule. ROW is now scheduled in FFY17. CON is anticipated to occur at the end of FFY17.
- 2. U-5530OA Trailwood Sidewalk (16, CON). This project is progressing on schedule, anticipated to authorize construction at the end of FFY16.
- 3. U-5530OB Leesville Road SRTS Project (16, CON). This project is progressing on schedule, anticipated to authorize construction at the end of FFY16.
