**5.1 FY 2024 3rd Quarter Wake Transit Work Plan Amendment Requests**

*Benjamin Howell, CAMPO, presented this item.*

*Mr. Howell provided a brief overview of the 3rd Quarter Wake Transit Work Plan Amendments. He stated that the item had been through the public comment period and been presented to TPAC.*

*Mr. Howell stated that TPAC recommended moving forward with these amendments. He stated that the amendments are being presented for consideration and recommendation to the Executive Board approval at their February Board meeting.*

*Mr. Howell informed the TCC of the 2 amendments being recommended. One from the City of Raleigh for improvements to route 21 Caraleigh, and another from the City of Raleigh for additional funding for the New Bern Corridor Bus Rapid Transit Facility.*

*He noted that when the Caraleigh project was submitted, additional money was requested. However, the project sponsor has determined that no financial change is needed and the amendment is only a scope change.*

*Mr. Howell stated that the amendments were available for public review from December 8th to January 5th. He stated that 35 comments were received. Most were in support of the amendments, and others were not related to the them. After review by CAMPO staff, input was considered to relation to the Work Plan but did not result to any changes to the amendments.*

*Chair Tracy Stephenson opened the floor for questions.*

*Kenneth Ritchie motioned to recommend that the Executive Board approve the FY 2024 Quarter 3 Wake Transit Work Plan Amendment Requests.*

**5.2 US 401 Corridor Study - Final Phase**

*Chris Lukasina, CAMPO, presented this item.*

*Mr. Lukasina provided an overview of the 401 Study and its history. He noted the recommendation for the existing U.S. 401 in Wake County. These primarily focused on widening and access management improvements through Fuquay-Varina.*

*Mr. Lukasina noted that the study was multi-modal in nature. Therefore, it also looked at other modes of transportation, identifying areas for pedestrian and bicycle improvements.*

*He shared some recommendation in the Harnett County area, based on public feedback from the 1st three rounds of engagement. The study looked at a widening a 2 lane corridor at 55mph to a 4 lane at 45mph. He noted that two cross sections were looked at for Harnett County, which both concepts received public support.*

*Mr. Lukasina informed the TCC that there were many intersection improvements along the 401 corridor. He stated that they had strong public support for all intersection improvement recommendations.*

*Mr. Lukasina stated that there were many alternatives looked at for the future 401 alignment. He noted that final phases were completed at the request of the Executive Board, and helped push for public engagement this past Fall. He stated that support on this alignment had not been unanimous. There were strong feelings for and against all of the alternatives, primarily focused on property impacts.*

*Mr. Lukasina expressed that many responses stated that 45mph speed was too low, and that they preferred a 55mph or higher speed limit with a narrower corridor. He noted that in earlier rounds of engagement, that there was a desire to attempt minimizing the impacts of that future corridor, this was why a 45mph design speed alternative was created. He also noted that this project is still in planning phase.*

*Mr. Lukasina informed the TCC that the final report and recommendation is scheduled for a public comment period starting February 19th through March 20th. It will be presented to the TCC again in March for recommendation.*

*Chair Stephenson opened the floor for questions and/or comments.*

*Chandler Hagen, CAMPO, presented this item.*

*Chandler Hagen presented the FFY 25 LAPP Investment Program recommendations made by the Selection Committee in December. Based on Raleigh's late withdrawal from the FFY 24 LAPP Investment Program, the Selection Panel had recommended requiring Raleigh to confirm their ability to authorize the FFY 25 construction funding by the end of June 2024. In the event that Raleigh was unable to accept the FFY 25 award, the Selection Panel recommended an alternative FFY 25 LAPP Investment Program that would not fund Raleigh and would instead fund the next two highest scoring roadway projects (ranked 5 and 6).*

*Chair Stephenson opened the floor for questions and/or comments.*

*Cate Farrell, Town of Zebulon, noted that as a project recipient under the alternative FFY 25 LAPP Investment Program, the Town needed more time to appropriately plan for funding discussions that will take place in June. She suggested that Raleigh be given until the end of February to confirm their ability to accept the FFY 25 funding. She also explained that she had met with Raleigh and felt they should be able to reach a decision by the end of February based on their planned presentation to City Council in February.*

*Kenneth Ritchie, City of Raleigh, confirmed that they did hope to have direction by that date but could not guarantee that a decision would be made in February. He stated that it could possibly be delayed to the meeting in March.*

*Shelby Powell noted that the meeting in March would take place before the March TCC meeting, therefore Raleigh could expect to have an answer by the next TCC meeting.*

*Chris Lukasina noted that the Executive Board could choose to accept the Selection Panel's recommendations or the TCC modified recommendation.*

*Paul Black motioned to recommend approval of the FFY 25 LAPP Investment Program with a deadline of the March TCC meeting for decision from the City of Raleigh on the Six Forks Road Project.*

*Bynum Walter seconded that motion.*
