The metropolitan planning organization (MPO), in cooperation with the designated recipient of federal formula transit grants (City of Raleigh/GoRaleigh) for the Raleigh, North Carolina, Urbanized Area, seeks your assistance with the distribution of the FFY 2025 Section 5307/5340 and Section 5339 Federal Transit Administration (FTA) formula apportionments.
