*Ms. Gretchen Vetter gave an update on the FFY 2019 Locally Administered Projects Program (LAPP).*

*The update was based on the Target Modal Investment Mix with Alternative Options and recommended proposed changes to the FFY 2019 LAPP Program for public review and comments from June 16th through August 16th, 2017 with a Public hearing scheduled at the regular Executive Board Meeting on August 16th, 2017 at 4:00pm and also with this based on the Executive Boards action at that meeting a call for Projects are anticipated to open on August 16th, 2017.*

*Danny Johnson - Asked: which one of the Alternatives or original staff recommendations are both going to Executive Board.*

*Ms. Vetter - Answered: She believes they are going to bring a final recommendation to the Executive Board.*

*Danny Johnson also stated he was one of the ones that advocated a little bit of adjustment to the bike and pad and just wanted to support the adjustment. He thinks the adjustment is reasonable. Mr. Johnson thinks that when we move forward the actual application can be reevaluated like Ms. Vetter said and the adjustment can be shifted to the other plummet mix of the resolves application score and if you don't get enough competitive projects there. Not going into why or what because I saw in the other graph that there was a drop in last year's work and it could be for varies reason for it so not going to go into it. Mr. Johnson stated he will support using the Alternative.*

*Jason Myers - Are you asking the TCC Board to recommend one of those options, but you are also saying you are going to wait for the public comments and then CAMPO Staff is going to make recommendations?*

*Ms. Vetter stated that public comments are open until August 16, 2017. This is the same day as the Executive Board meeting and also there will be a public hearing and that public comments are still being collected as of now.*

*Mr. Chris Lukasina gave an update on development of the 2045 Metropolitan Transportation Plan (2045 MTP/CTP). Mr. Lukasina discussed the status of socio-economic data development. He also provided a review of the Alternatives Analysis results. He described the two scenarios and highlighted the major roadway and transit projects in each scenario. He presented the tomato map and travel time isochronal maps for each scenario as well as a comparison of several measures of effectiveness for both alternative scenarios and a comparison to the base year and the deficiency analysis results from previous meetings. Mr. Lukasina stated that copies of the alternatives analysis results as well as mapping products would be available online after the meeting. Mr. Lukasina concluded his presentation by reviewing the current MTP development schedule.*

**8. Informational Item: Staff Reports**

*MPO Director, Chris Lukasina*

*Mr. Lukasina stated that the Southeast Area Study final documentation report should be available next week and will be sent out and for those that are in the study area there will be a two week turnaround time for review with any comments on those final work products. This is the last step and asking to give back to Alex Rickard at CAMPO.*

*Mr. Lukasina wanted to remind the TCC members that assuming that the Executive Board approves and agrees with the recommendations on the LAPP program. The window will open and the LAPP season will be open also. The LAPP applicant training is tentatively scheduled for August 17, 2017 at 9:00am here at the CAMPO office. For those that are planning on submitting for the FFY19 round of LAPP need to be ready to sign up as soon as you see the notice goes out.*

*Mr. Lukasina gave an update on the two positions that were open. The TPAC and the Public Engagement positions have been offered and accepted, but these are conditional offers for the next two weeks at this point. Hopefully they will be finalized and we anticipate the TPAC Administrator will be coming on board in mid-August and the Public Engagement to be coming in mid-September.*

*Mr. Lukasina stated in the next couple of weeks the Member shares bills from the last fiscal year will be going out in the next couple of weeks.*

*Mr. Lukasina reported that there were 3 projects that got started later than anticipated in the fiscal year. These projects will carry forward a little longer due to contracts and agreements.*

*Mr. Lukasina stated that we have secured 2 firms for CAMPO legal services and they both have experience in both in Local Government work in this area. Some level of experience with MPO, state and federal Government.*

*Mr. Lukasina and Mr. Rickard stated as a reminder if the Executive Board does open up a call for projects for LAPP and UPWP and traditionally it's for the next MTP but since we are where we are with the MTP process if anybody has a new project we will be a surprise. Corridor studies, Hot SPOTs and Special Studies for next year.*
