Community Funding Area PMP Update - September 2025

Ms. Plancich provided an overview of the Community Funding Area Program Management Plan and projects funded to date, noting that the Plan was last updated in 2020. We are on schedule to adopt the Update before the FY 2027 application cycle, which starts in January 2026. She commented that the update process has taken longer than anticipated due to the first draft not being well received and the need for more data. After additional data collection and meetings with partners, this most recent draft was well received, and it is currently out for public comment until October 21, 2025. She highlighted the following major revisions in the Update and presented the adoption timeline:

- · Added Unincorporated Wake County as an Eligible area/applicant
- Lowered Local Match Requirement from 50% to 35%
- · Removed funding cap on Planning/Technical Assistance Projects
 - Establish 3% Target for Planning funding each year
 - Projects still required to provide 35% Local Match
- · Increased overall funding for CFA Program
 - Tripled funding from \$20M over next 10 years to \$60M
 - All CFA project funding will come from this pot of money
- · Revised Scoring Criteria to account for new match requirement
- · Added appendix providing options to consider in future for graduation framework
- Added clarification of process for scope and/or budget changes during Annual Review process

- Moving FFY25 projects to FFY26
- Changes due to the State STIP: June September 2025

7.2 Safety Performance Measure Targets 2026

Blueprint for Safety Target Setting - 2026

Mr. Withrow provided an overview of the requirements for adopting targets for the following safety performance measures, noting how CAMPO has historically mirrored NCDOT's targets and the fact that CAMPO is now able to set its own targets:

- 1. Number of fatalities
- 2. Rate of fatalities (per 100 million VMT)
- 3. Number of serious injuries
- 4. Rate of serious injuries (per 100 million VMT)
- 5. Number of non-motorized (Pedestrian & Bicycle) fatalities and non-motorized serious injuries

Mr. Withrow stated that, on April 16, 2025, the Executive Board endorsed the goals of a 50% reduction of fatal and serious injury crashes by 2055 and ultimately moving toward zero fatal and serious injury crashes by applying the noted short-term, mid-term, and long-term goals to set annual FHWA safety targets:

- Near-Term (2025-2035):To achieve the ultimate long-term goal, an interim goal for the 2025-2035 horizon is to reduce serious injury and fatal crashes by 10% (An annual 1% reduction).
- Mid-Term (2036-2045): During the 2036-2045 horizon, CAMPO's goal will shift to a more aggressive reduction in serious injury and fatal crashes by an additional 15-20% (a 2% annual reduction).
- Long-Term (2046-2055): During the 2046-2055 horizon, an ambitious goal will be set to reduce serious injury and fatal crashes by at least an additional 30% (a 4% annual reduction).

Mr. Withrow then illustrated CAMPO's 2026 targets based on its near-term goal of reducing crashes by 1% annually and announced that the public comment period ends on November 18, 2025, with the public hearing being scheduled for November 19, 2025.

Responding to Board Member Harold Weinbrecht's question regarding data on technology driving safety improvements, Mr. Withrow stated that, along with collecting such data, we are looking at a two-fold exercise in culture and policy changes. He added that the matter will be addressed further at the Blueprint for Safety Implementation Summit being held on December 3, 2025.

Chris Lukasina stated that the results of today's investments in infrastructure will not show up for some time. He noted that many technological advances have only been in place for a few years and that he is not sure how much data has been collected on them. He spoke regarding an NCDOT pilot program to identify causes of lane departures and the results showing that there were a lot of small ways to improve safety in those corridors, including signage and mowing. He added that CAMPO is talking with NCDOT about doing something similar here.

Mr. Lukasina provided the monthly 2055 MTP/CTP Update, noting that we are quickly getting to a draft plan. He provided highlights of the Preferred Scenario Transit Element and the proposed major transit investments.

Responding to Board Member Janet Cowell's inquiry regarding the project near Highway 70, Mr. Lukasina stated that it is a future BRT corridor along Highway 70 to Brier Creek. It's planned 15-20 years out from now and is only conceptual at this point.

Mr. Lukasina next provided highlights of the Preferred Scenario Roadway and Bike/Ped Elements and the proposed major roadway and bike/ped investments, as well as an overview of the 2055 MTP Revenue Forecast comparing available traditional funding sources to the region's identified needs at the statewide, regional, and division levels. He presented the preliminary 2055 MTP financials and noted that we are continuing to tweak the numbers as more information is received. He provided an overview of the recommended revenue option, noting that it will fund an additional 42 projects, and stated that all of the analyses and data for all options and scenarios explored is still being updated and maintained online at

https://www.campo-nc.us/transportation-plan/in-development-2055-mtp. He commented that CAMPO is continuing to work with member agencies' staffs to make any tweaks or updates necessary. He announced that we are in the next phase of public engagement and that the 42-day public comment period ends on November 18, 2025. He noted that the online survey closes on November 13, 2025, and that the public hearing is scheduled for November 19, 2025. He then reminded everyone about the two-step adoption process and presented the anticipated milestone dates towards a final Plan adoption in February 2026.

Mr. Spruill provided an overview of the Strategic Regional Rail Infrastructure Investment Study and the process. He provided comparisons of rail terminology in relation to service concepts, noting that the focus of this Study was on passenger rail. He stated that the project tasks for the Study included looking at Service Concepts, the Project Universe, Federal/State Project Funding Screening, the Local Decision-Making Framework, and Future Study Recommendations. He explained that the Joint Rail Sub-Committee met in December 2024 to identify a vision for what regional rail would look like and that the Service Concepts proposed are meant to be a framework to start from. The Project Universe component was created to address bottlenecks and includes all of the projects needed to bring each proposed segment online. He noted that some projects will improve multiple segments and that the full project matrix includes federal and state funding availabilities and attractiveness considerations. He next provided an overview of the Local Decision-Making Framework and its Five Principles, the Strategic Investment Decision Tree which provides a priority order for investments allowing incremental progress while larger programmatic investments are pursued, and highlighted Future Study areas. He spoke regarding the discussions on when the Study should be updated next and stated that it was recommended that the Study be reevaluated in two to four years. He noted that it is easier to get federal funding for improvements to existing service than new service and spoke regarding the potential option of creating a new. "slow service" route and then seeking federal funds to expand that service. He commented that this presentation will also be made at the October 29, 2025, Joint CAMPO-TWTPO Board meeting. He added that a notice of \$5 billion in federal funding opportunities was announced two weeks ago, with the submission deadline being January 7, 2026, and stated that efforts to coordinate grant applications will be discussed at the October 29, 2025, Joint CAMPO-TWTPO Board meeting.

Responding to Board Member Stephen Morgan's question as to whether "slow service" was a reference to train speed, Shelby Powell stated it could reference train speed or the roll out of the project. The idea of "slow service" is to build some level of service for the future purpose of accessing additional federal funds later. She added that the Joint Rail Sub-Committee recommended that the option be studied to see if it is worth pursuing.

Board Member Morgan commented that the option makes sense and that some of the train speed limits could possibly be increased. Mr. Spruill responded that the issue of train speeds would be addressed in a future Network Rail Operations Study.

There were no further questions and/or comments.

Board Member Janet Cowell motioned to endorse the Strategic Regional Rail Infrastructure Investment Study and direct staff to continue coordination with partners to advance regional rail efforts. Board Member TJ Cawley seconded the

motion. The motion carried unanimously.
