- **Draft Wake Transit FY 2021 Annual Work Plan (TPAC Development)** The Public comment period hosted by the TPAC (Jan. 29 to Feb. 29) has concluded on the FY 2021 Draft Wake Transit Work Plan, Next, the TPAC will develop and review a Recommended FY 2021 Wake Transit Work Plan in April of 2020 to be presented to CAMPO and GoTriangle for adoption by July 1, 2020. CAMPO will host a 30-day public comment period and public hearing for the adoption of the recommended plan, likely to occur between April-May.
