This memorandum and its attachments detail the timing, expectations and other parameters for Wake Transit FY 2018 Operating and Capital Agreements.

# Agreements are Required:

As directed by the Wake Transit Governance Interlocal Agreement (Governance ILA) and reaffirmed by the Wake Transit Participation Agreement (Participation Agreement), annual appropriations for operating and capital projects in the Wake Transit Work Plan require capital funding agreements and operating agreements. These agreements detail the expectations, roles and responsibilities of all parties. No Wake Transit Tax Revenue shall be spent prior to execution of an operating or capital agreement by all parties.

#### Logical Grouping of Implementation Elements and/or Projects:

The Governance ILA and the Participation Agreement allow for multiple implementation elements to be grouped under a single agreement. The Process subcommittee has worked with the two other TPAC subcommittees to categorize the implementation elements (projects) identified in the FY 2018 Wake Transit Work Plan by Operating or Capital Funding Agreements, and then by a specific type of operating or capital funding agreement. Attachment 1 details the FY 2018 Wake Transit Work Plan projects and their agreement categories. A summary of the types of agreement for the FY 2018 Wake Transit Work Plan is below:

- 1) Operating Funding Agreements
  - a) Bus Operations Agreement
  - b) Transit Plan Administration Agreement
  - c) Tax District Administration Agreement
  - d) Special Operating Agreement
- 2) Capital Funding Agreements
  - a) General Capital Agreement
  - b) Special Capital Agreement

#### **Content of Agreements:**

The Governance ILA and the Participation Agreement state that the Operating and Capital Agreements are required to hold all parties accountable to specific actions and metrics. All agreements under development detail in the body of the agreement or in its attachments, the parties, the period of performance, terms and conditions, reporting requirements, billing, scope and deliverables, and breach provisions for the agreement and for the implementation elements covered.

The Governance ILA and the Participation Agreement state that regular progress reports and updates will be developed for all implementation elements funded. The language in the agreements includes requirements for performance reporting quarterly and annually. The agreements also charge the implementing party with proactively notifying the other parties and the TPAC of issues and concerns. The Process and Prioritization Subcommittee will be reviewing a uniform reporting template for the reporting of deliverables.

An Exhibit A was developed for each operating and capital agreement. These exhibits list parties to the agreement, amounts appropriated, project budgets, scope, projected implementation dates, and deliverables to be reported on a quarterly and annual basis. The Exhibit A for general operating and general capital agreements are attached. The Exhibit A for the special operating and special capital agreements are still being developed, but will detail similar aspects and other essential to project delivery.

#### **Timing of Agreements:**

The Governance ILA anticipated that all agreements would be developed and recommended by TPAC when it recommended the annual transit Work Plan. Agreements would then be adopted as part of the Wake Transit Work Plan adoption process. We recommend that some agreements for the proposed implementation elements (projects) be developed later if additional information is needed and funds are not needed to be spent at the beginning of a given fiscal year. Other agreements that are routine would be presented to the TPAC with the annual work plan. In practice this may result in certain items being budgeted but operating and capital agreements not finalized until later in the fiscal year. For FY 2018, the special operating and capital agreements are still being developed, and will be presented to TPAC for recommendation at a later date.

# GENERAL OPERATING AGREEMENT FOR TRANSIT PLAN ADMINISTRATION

## **WAKE TRANSIT FY 2018**

This Operating Agreement ("Agreement") is made by and between Research
Triangle Regional Public Transportation Authority, d/b/a GoTriangle ("GoTriangle") and
("Implementing Party") and Capital Area
Metropolitan Planning Organization ("CAMPO"). The foregoing may collectively
be referred to as "Parties."

WHEREAS, Wake County, GoTriangle and CAMPO have adopted a governance structure for the implementation of the Wake Transit Plan by and through annual plans ("Wake Transit Work Plans") through the Wake Transit Governance Interlocal Agreement ("Governance ILA"); and

WHEREAS, the Governance ILA created the Transportation Planning Advisory Committee ("TPAC"), which has representation from all Wake County Municipalities, GoTriangle, CAMPO, Wake County, NC State and RTP, which is responsible for coordinating and recommending the planning and implementation of the Wake Transit Work Plan, and

WHEREAS, municipalities and entities eligible to receive funding through the Wake Transit Work Plans shall be signatories to the Wake Transit Master Participation Agreement ("Participation Agreement") and shall enter into an operating agreement per the Governance ILA; and

WHEREAS, the Parties to this Agreement are current signatories to the Participation Agreement, and

WHEREAS, the FY 2018 Wake Transit Work Plan was developed by the TPAC, presented for public comment, and adopted, as required, by the Boards of CAMPO and GoTriangle, and

WHEREAS, the FY 2018 Triangle Tax District Wake Operating Ordinance was adopted by the GoTriangle Board of Trustees on June 28, 2017, and

WHEREAS, the Parties desire to implement the components of the 2018 Wake Transit Work Plan as adopted by GoTriangle and CAMPO;

NOW, THEREFORE, in consideration of the above recitals and the mutual covenants herein contained, the Parties hereto agree as follows:

#### 1. **Term:**

The Agreement commences upon execution of the last party and terminates on December 31, 2018. The Parties may extend the term of this Agreement or may otherwise amend this Agreement as set forth in Section 7.

#### 2. Scope & Funding:

The Parties agree to the provision of services detailed in the attached Exhibit A.

Funds are appropriated from the FY 2018 Triangle Tax District Wake Operating Ordinance, approved by GoTriangle, in accordance with the Transit Governance ILA. The specific appropriation and approved project budgets are further detailed in the attached Exhibit A and in the FY 2018 Wake Transit Work Plan.

Implementing Agencies shall:

- (1) Ensure that Wake Transit funds provided by GoTriangle are not misappropriated or misdirected to any other account, need, project, or line item.
- (2) Monitor award activities, to include sub-awards, to provide reasonable assurance that funds are spent in compliance with applicable requirements. Responsibilities include the accounting receipts and expenditures, cash management, maintaining adequate financial records, and refunding disallowed expenditures.
- (3) By signature of this agreement, verify that they have, or will implement, a financial management system adequate for monitoring the accumulation of costs.

#### 3. Billing

## A. Responsibilities of the Implementing Party.

The Party shall fund the cost of the projects pursuant to Exhibit A on an upfront basis. The Implementing Party is responsible for ensuring funds are available to pay for the projects on Exhibit A prior to reimbursement by GoTriangle.

In special circumstances where an advance payment may be required, requests must be submitted using the Billing, Payment, and Reimbursement Template and with a justification for the advance payment request. Advance payments received by the Implementing Party must be disbursed within 72 hours of receipt from GoTriangle.

Requests for reimbursement may be submitted by the local participating entity as often as it is efficient and effective for the implementing party. The

reimbursement request shall be emailed to waketransitreimbursement@gotriangle.org.

All submissions must use the pre-approved Billing, Payment, and Reimbursement Template and include a signed statement by the requesting agency's Finance Officer or designee stating that funds were spent in accordance to the Wake Transit Work Plan and with laws, rules, and regulations and that the request for funds includes items due and payable. All requests shall be based on actual expenses incurred as recorded in the financial system.

Final reimbursements for expenses incurred as of June 30th shall be submitted by August 10, 2018.

## B. Responsibilities of GoTriangle.

GoTriangle, as administrator of the Triangle Tax District, shall adhere to its responsibilities and obligations as set forth in the Governance ILA. GoTriangle will verify within five business days upon receipt, that the request is within the approved budget and it is in accordance with the Wake Transit Billing, Payment, and Reimbursement Policy and Guidelines, including receipt of the signed statement from the finance officer or designee. Payment will be remitted within thirty (30) days upon verification to the Implementing Party via payment instructions on file. In special circumstances where advance payment are requested, GoTriangle, after due consideration of the request, will remit funds via payment instructions on file.

All disbursements from GoTriangle will be in accordance with North Carolina General Statute 159 Article 3, known as the North Carolina Budget and Fiscal Control Act and the Wake Transit Financial Policies and Guidelines.

## 4. **Performance Reporting:**

The Implementing Party agrees to provide to provide quarterly and annual reporting for the Reported Deliverables as identified in Exhibit A in accordance with Section 8.02 of the Wake Transit Governance ILA using the pre-approved Wake Transit Reporting Template. The parties agree to share supporting documentation, if requested, in addition to the quarterly and annual reporting within the timeframes outlined within North Carolina General Statute pertaining to public records requests.

The Annual Wake Transit Report shall provide information regarding meeting strategic public transit objectives and include the performance achieved, the strategies being followed, and performance targets and key milestones for capital projects and operating services.

Quarterly Status Reports shall provide information regarding progress toward

strategic objectives outlined in the Wake Transit Work Plan and includes the performance achieved, the strategies being following, and performance targets and key milestones for Capital Projects and operating services identified in the Wake Transit Work Plan.

## 5. **Further Agreements:**

The Parties shall enter into such further agreements among themselves as required for the efficient coordination and delivery of the operations as set forth in Exhibit A. Such further agreements shall be subject to this Agreement and the adopted FY18 Wake County Work Plan.

#### 6. **Amendment:**

Any extension of the term of this Agreement and/or change to the content of this Agreement shall be by written amendment signed by all Parties.

#### 7. **Severability**

If any provision of this Agreement or the Exhibits hereto are found to be unenforceable or if there is a breach of a specific provision, the remainder of the Agreement shall remain in full force and effect.

# 8. <u>Inability or Failure to Provide Project(s) or Implementation Element(s)</u> ("Breach"):

In the event that there is an inability or a failure to provide project(s) or implementation element ("breach") under the Agreement, the "breaching" Party shall provide sufficient notice to the TPAC Administrator and to the Parties to this Agreement. In their quarterly reporting, Parties are required to include any details of issues that may impact successful delivery of the projects or implementation element(s) as identified in Exhibit A.

Upon the TPAC administrator receiving notice of the "breach", the matter will be added to the TPAC meeting schedule. The TPAC will discuss the portion of the Agreement that is at issue and the majority of the TPAC shall make a recommendation on how to proceed. The Agreement may be terminated or amended based on recommendations from the TPAC.

The TPAC may provide the Implementing Party with a period of time to cure the breach to the reasonable satisfaction of the non-breaching party(ies). If the breach is not timely cured, or cannot be cured, the non-breaching Parties may elect to remove the breaching Party from the Agreement by an amendment that shall not require the signature of the breaching Party.

If a Party elects to withdraw from the Master Participation Agreement, shall serve

as immediate notice of a "breach" of this Agreement.

In the event the Agreement is terminated, parties may be required to satisfy any existing obligations to the satisfaction of the Parties.

In the event the Agreement is terminated, the TPAC shall amend their work plan to remove the specific project(s).

## 9. Record Retention:

All parties must adhere record retention guidelines as set forth in North Carolina General Statutes or federal guidelines as appropriate

## 10. Notices

Any notice given pursuant to this Agreement shall be deemed given if delivered by hand or if deposited in the United States Mail, postage paid, certified mail, return receipt requested and addressed as follows:

## 11. Representations and Warranties:

The Parties each represent, covenant and warrant for the other's benefit as follows:

- A. Each Party has all necessary power and authority to enter into this Agreement and to carry out the transactions contemplated by this Agreement, and this Agreement has been authorized by each Party's governing body. This Agreement is a valid and binding obligation of each Party.
- B. To the knowledge of each Party, neither the execution and delivery of this Agreement, nor the fulfillment of or compliance with its terms and conditions, nor the consummation of the transactions contemplated by this Agreement, results in a breach of the terms, conditions and provisions of any agreement or instrument to which a Party is bound, or constitutes a default under any of the foregoing.
- C. To the knowledge of each Party, there is no litigation or other court or administrative proceeding pending or threatened against such party (or against any other person) affecting such Party's rights to execute or deliver this Agreement or to comply with its obligations under this Agreement. Neither such Party's execution and delivery of this Agreement, nor its compliance with its obligations under this Agreement, requires the approval of any regulatory body or any other entity the approval of which has not been obtained.
- D. The Parties agree to work together in good faith and with all due diligence to provide for and carry out the purpose of this Operating Agreement.

## 12. Merger and Precedence:

The provisions of this Agreement, including all Exhibits and attachments, constitute the entire agreement by and between the Parties hereto and shall supersede all previous communications, representations or agreements, either oral or written between the Parties hereto with respect to the subject matter hereof. Notwithstanding the foregoing, in the event of any inconsistency or conflict between this Agreement and the Participation Agreement or the Governance ILA, the terms of the Participation Agreement and Governance ILA have precedence.

# 13. **Dispute Resolution:**

In the event of conflict or default that might arise for matters associated with this Agreement, the Parties agree to informally communicate to resolve the conflict. If any such dispute cannot be informally resolved, then such dispute, or any other matter arising under this Agreement, shall be subject to resolution in a court of competent jurisdiction. Such disputes, or any other claims, disputes or other controversies arising out of, and between the Parties shall be subject to and decided exclusively by the appropriate general court of justice of Wake County, North Carolina.

## 14. No Waiver of Non-Compliance with Agreement:

No provision of this Agreement shall be deemed to have been waived by any Party hereto unless such waiver shall be in writing and executed by the same formality as this Agreement. The failure of any Party hereto at any time to require strict performance by the other of any provision hereof shall in no way affect the right of the other Party to thereafter enforce the same. In addition, no waiver or acquiescence by a Party hereto of any breach of any provision hereof by another Party shall be taken to be a waiver of any succeeding breach of such provision or as a waiver of the provision itself.

#### 15. Governing Law:

The Parties intend that this Agreement be governed by the law of the State of North Carolina. Proper venue for any action shall solely be Wake County.

#### 16. **Assignment:**

No Party may sell or assign any interest in or obligation under this Agreement without the prior express written consent of the other Parties.

# 17. Independence of the Parties:

Nothing herein shall be construed to modify, abridge, or deny the authority or discretion of any Party to independently develop, administer, or control transportation projects pursuant to enumerated authority or funding sources separate from those in this Agreement.

# 18. <u>Execution in Counterparts/Electronic Version of Agreement:</u>

This Agreement may be executed in any number of counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument. Any Party may convert a signed original of the Agreement to an electronic record pursuant to a North Carolina Department of Natural and Cultural Resources approved procedure and process for converting paper records to electronic records for record retention purposes. Such electronic record of the Agreement shall be deemed for all purposes to be an original signed Agreement.

#### 19. No Waiver of Sovereign Immunity:

Nothing in this Agreement shall be construed to mandate purchase of insurance by Wake County pursuant to N.C.G.S. 153A-435 or purchase of insurance by any Municipality pursuant to N.C.G.S. 160A-485; or to be inconsistent with Wake County's "Resolution Regarding Limited Waiver of Sovereign Immunity" enacted October 6, 2003; or to in any other way waive any Party's defense of sovereign or governmental immunity from any cause of action alleged or brought against any Party for any reason if otherwise available as a matter of law.

## 20. No Waiver of Qualified Immunity:

No officer, agent or employee of any Party shall be subject to any personal liability by reason of the execution of this Agreement or any other documents related to the transactions contemplated hereby. Such officers, agents, or employees shall be deemed to execute this Agreement in their official capacities only, and not in their individual capacities. This section shall not relieve any such officer, agent or employee from the performance of any official duty provided by law.

#### 21. Verification of Work Authorization; Iran Divestment Act:

All Parties, and any permitted subcontractors, shall comply with Article 2, Chapter 64, of the North Carolina General Statutes. The Parties hereby certify that they, and all permitted subcontractors, if any, are not on the Iran Final Divestment List created by the North Carolina State Treasurer pursuant to N.C.G.S. 147-86.58.

## 22. No third-Party Beneficiaries:

There are no third-party beneficiaries to this Agreement.

All disbursements from GoTriangle will be in accordance with North Carolina General Statute 159 Article 3, known as the North Carolina Budget and Fiscal Control Act and the Wake Transit Financial Policies and Guidelines.

#### 4. Minimum Service Standards:

The Parties agree to provide the high quality service in the implementation of the adopted FY2018 Wake Transit Work Plan and shall, at a minimum:

- A. Maintain all vehicles and facilities in accordance with a preventative maintenance program.
- B. Maintain the vehicles and facilities in a safe and dependable condition and cleaned regularly.
- C. Monitor services and respond to incidents in a timely and accurate manner.
- D. Conduct regular reviews of service including: safety, on-time performance, customer satisfaction, accessibility, cleanliness, security and records of

- customer service training.
- E. Conduct public engagement activities in accordance with state and federal guidelines and agency and municipal policies and procedures, if applicable.

#### 5. **Performance Reporting:**

Unless otherwise agreed in writing between Parties, each Implementing Party shall report operating statistics and ridership to the National Transit Database and to the North Carolina Department of Transportation Public Transportation Division.

The Implementing Agency also agrees to provide quarterly and annual reporting for the Reported Deliverables as identified in Exhibit A and as required by Section 6.01 and Section 8.02 of the Wake Transit Governance ILA using the pre-approved Wake Transit Reporting Template. The parties agree to share supporting documentation, if requested, in addition to the quarterly and annual reporting within the timeframes outlined within North Carolina General Statute pertaining to public records requests.

The Annual Wake Transit Report shall provide information regarding meeting strategic public transit objectives and include the performance achieved, the strategies being followed, and performance targets and key milestones for capital projects and operating services.

Quarterly Status Reports shall provide information regarding progress toward strategic objectives outlined in the Wake Transit Work Plan and includes the performance achieved, the strategies being following, and performance targets and key milestones for Capital Projects and operating services identified in the Wake Transit Work Plan.

#### 6. Further Agreements:

The Parties shall enter into such further agreements among themselves as required for the efficient coordination and delivery of the operations as set forth in Exhibit A. Such further agreements shall be subject to this Agreement and the adopted FY18 Wake County Work Plan.

#### 7. **Amendment:**

Any extension of the term of this Agreement and/or change to the content of this Agreement shall be by written amendment signed by all Parties.

# 8. **Severability**

If any provision of this Agreement or the Exhibits hereto are found to be unenforceable or if there is a breach of a specific provision, the remainder of the Agreement shall remain in full force and effect.

# 9. <u>Inability or Failure to Provide Project(s) or Implementation Element(s)</u> ("Breach"):

In the event that there is an inability or a failure to provide project(s) or implementation element ("breach") under the Agreement, the "breaching" Party shall provide sufficient notice to the TPAC Administrator and to the Parties to this Agreement. In their quarterly reporting, Parties are required to include any details of issues that may impact successful delivery of the projects or implementation element(s) as identified in Exhibit A.

Upon the TPAC administrator receiving notice of the "breach", the matter will be added to the TPAC meeting schedule. The TPAC will discuss the portion of the Agreement that is at issue and the majority of the TPAC shall make a recommendation on how to proceed. The Agreement may be terminated or amended based on recommendations from the TPAC.

The TPAC may provide the Implementing Party with a period of time to cure the breach to the reasonable satisfaction of the non-breaching party(ies). If the breach is not timely cured, or cannot be cured, the non-breaching Parties may elect to remove the breaching Party from the Agreement by an amendment that shall not require the signature of the breaching Party.

If a Party elects to withdraw from the Master Participation Agreement, shall serve as immediate notice of a "breach" of this Agreement.

In the event the Agreement is terminated, parties may be required to satisfy any existing obligations to the satisfaction of the Parties.

In the event the Agreement is terminated, the TPAC shall amend their work plan to remove the specific project(s).

#### 10. ADA and Paratransit Requirements:

The Parties shall provide paratransit service within the ADA-required radius of their all day fixed-route bus services.

#### 11. Record Retention:

All parties must adhere record retention guidelines as set forth in North Carolina General Statutes or federal guidelines as appropriate

## 12. Notices

Any notice given pursuant to this Agreement shall be deemed given if delivered by hand or if deposited in the United States Mail, postage paid, certified mail, return receipt requested and addressed as follows:

#### 13. Representations and Warranties:

The Parties each represent, covenant and warrant for the other's benefit as follows:

- A. Each Party has all necessary power and authority to enter into this Agreement and to carry out the transactions contemplated by this Agreement, and this Agreement has been authorized by each Party's governing body. This Agreement is a valid and binding obligation of each Party.
- B. To the knowledge of each Party, neither the execution and delivery of this Agreement, nor the fulfillment of or compliance with its terms and conditions, nor the consummation of the transactions contemplated by this Agreement, results in a breach of the terms, conditions and provisions of any agreement or instrument to which a Party is bound, or constitutes a default under any of the foregoing.

- C. To the knowledge of each Party, there is no litigation or other court or administrative proceeding pending or threatened against such party (or against any other person) affecting such Party's rights to execute or deliver this Agreement or to comply with its obligations under this Agreement. Neither such Party's execution and delivery of this Agreement, nor its compliance with its obligations under this Agreement, requires the approval of any regulatory body or any other entity the approval of which has not been obtained.
- D. The Parties agree to work together in good faith and with all due diligence to provide for and carry out the purpose of this Operating Agreement.

## 14. Merger and Precedence:

The provisions of this Agreement, including all Exhibits and attachments, constitute the entire agreement by and between the Parties hereto and shall supersede all previous communications, representations or agreements, either oral or written between the Parties hereto with respect to the subject matter hereof. Notwithstanding the foregoing, in the event of any inconsistency or conflict between this Agreement and the Participation Agreement or the Governance ILA, the terms of the Participation Agreement and Governance ILA have precedence.

# 15. **Dispute Resolution:**

In the event of conflict or default that might arise for matters associated with this Agreement, the Parties agree to informally communicate to resolve the conflict. If any such dispute cannot be informally resolved, then such dispute, or any other matter arising under this Agreement, shall be subject to resolution in a court of competent jurisdiction. Such disputes, or any other claims, disputes or other controversies arising out of, and between the Parties shall be subject to and decided exclusively by the appropriate general court of justice of Wake County, North Carolina.

## 16. No Waiver of Non-Compliance with Agreement:

No provision of this Agreement shall be deemed to have been waived by any Party hereto unless such waiver shall be in writing and executed by the same formality as this Agreement. The failure of any Party hereto at any time to require strict performance by the other of any provision hereof shall in no way affect the right of the other Party to thereafter enforce the same. In addition, no waiver or acquiescence by a Party hereto of any breach of any provision hereof by another Party shall be taken to be a waiver of any succeeding breach of such provision or as a waiver of the provision itself.

#### 17. Governing Law:

The Parties intend that this Agreement be governed by the law of the State of North Carolina. Proper venue for any action shall solely be Wake County.

## 18. **Assignment:**

No Party may sell or assign any interest in or obligation under this Agreement without the prior express written consent of the other Parties.

#### 19. Independence of the Parties:

Nothing herein shall be construed to modify, abridge, or deny the authority or discretion of any Party to independently develop, administer, or control transportation projects pursuant to enumerated authority or funding sources separate from those in this Agreement.

# 20. Execution in Counterparts/Electronic Version of Agreement:

This Agreement may be executed in any number of counterparts, each of which shall be an original and all of which shall constitute but one and the same instrument. Any Party may convert a signed original of the Agreement to an electronic record pursuant to a North Carolina Department of Natural and Cultural Resources approved procedure and process for converting paper records to electronic records for record retention purposes. Such electronic record of the Agreement shall be deemed for all purposes to be an original signed Agreement.

#### 21. No Waiver of Sovereign Immunity:

Nothing in this Agreement shall be construed to mandate purchase of insurance by Wake County pursuant to N.C.G.S. 153A-435 or purchase of insurance by any municipality pursuant to N.C.G.S. 160A-485; or to be inconsistent with Wake County's "Resolution Regarding Limited Waiver of Sovereign Immunity" enacted October 6, 2003; or to in any other way waive any Party's defense of sovereign or governmental immunity from any cause of action alleged or brought against any Party for any reason if otherwise available as a matter of law.

#### 22. No Waiver of Qualified Immunity:

No officer, agent or employee of any Party shall be subject to any personal liability by reason of the execution of this Agreement or any other documents related to the transactions contemplated hereby. Such officers, agents, or employees shall be deemed to execute this Agreement in their official capacities only, and not in their individual capacities. This section shall not relieve any such officer, agent or employee from the performance of any official duty provided by law.

# 23. Verification of Work Authorization; Iran Divestment Act:

All Parties, and any permitted subcontractors, shall comply with Article 2, Chapter 64, of the North Carolina General Statutes. The Parties hereby certify that they, and all permitted subcontractors, if any, are not on the Iran Final Divestment List created by the North Carolina State Treasurer pursuant to N.C.G.S. 147-86.58.
