CAMPO Projects – Public Engagement Updates

2050 MTP – Scenarios & Alternatives Analysis

Leading up to the Alternatives Analysis phase of MTP development, long-term goals have been established, the bulk of the data collection and analysis has occurred, and scenario variables have been identified. Modelling has begun, and, based on the scenarios being tested, two to four alternative options will be developed. During this phase of public engagement, the project team will:

- Share project progress and activities to date (journey)
- Describe the data and process used to develop alternatives
- Consult with the community on preferences related to the alternatives, likely the variables used to develop them, pros and cons of the independent alternatives (avoiding direct voting), and
- Also seek input on funding alternative revenues sources for transportation.

This public engagement on the Alternative Options is anticipated to begin in the spring.

Following engagement on the Alternatives, two additional phases of engagement are set to occur – one for feedback on the Preferred Option, and the final for the review and comment on the Draft 2050 MTP Recommendations (project lists and policies).

Northeast Area Study Update

The NEAS Update project team will be presenting to Town and County boards in the area throughout January to share an update on the project. A second round of public engagement is anticipated to begin early 2021. Additional details will follow soon regarding public engagement and outreach plans. 401 Corridor Study

The corridor study is now underway. One of the first deliverables by the consultants is a review of recent public engagement efforts in the area (related to transportation and land use), in order to build on, and not duplicate, the work that already took place. That will be followed by a public engagement plan for the project. Actual engagement is likely to occur closer to the spring/summer of 2021.

Triangle Bikeway Study

Initial public engagement for the Study wrapped in November 2020. The project team is now utilizing the community and stakeholder input to begin drafting alternative design scenarios on one leg, and the feasibility analysis for the other. Another phase of public engagement is anticipated when alternative options have been developed and vetted with the CTT and SOT for the study, likely toward the middle of 2020.

Public Engagement Planning (CAMPO)

CAMPO staff are actively engaged with public and stakeholder engagement planning for the following projects/studies. This is in addition to typical technical analysis, reviews, and engagement as key stakeholders for member organization projects (i.e. SPOT process, STIP/TIP project development, local Comprehensive Transportation Plans and transportation studies).

GoWake Access is currently in the early phases of launching a pilot project studying the use of microtransit in the northeastern areas of Wake County. Microtransit is an on-demand service (similar to Lyft or Uber) that allows users to request same-day service from a pickup location to a specified location. The study area includes the towns of Zebulon, Rolesville, Wendell and the surrounding unincorporated areas. The project aim is to launch an on-demand service that provides residents with greater access to jobs, school, healthcare and other essential services.

Franklin County Bicycle & Pedestrian Plan Charrette (Virtual)

Franklin County is developing a bicycle and pedestrian master plan. Through review of previous or ongoing planning & development efforts, remote and field analysis, and public involvement and stakeholder input, the team will identify a countywide recommended bicycle and pedestrian network. This project will consider infrastructure improvements such as sidewalks, crosswalks, bike lanes, and greenways in addition to complementary policies.
